Thank you for attending the public information meeting for the State Route 141 (Peachtree Parkway/Medlock Bridge Road) Corridor Study.

Project Description: The corridor study will follow SR 141 (Peachtree Parkway/Medlock Bridge Road) from Peachtree Industrial Boulevard/Holcomb Bridge Road and extend northward to the Chattahoochee River. It is being funded by the Atlanta Regional Commission whose funds are managed by the Georgia Department of Transportation. The purpose of this project is to develop viable, multimodal, transportation solutions and study the feasibility of improving the efficiency, operations, and safety of the SR 141 corridor. The project will also make short- and long-term improvement recommendations based on the following criteria:

- Consistency with the Cities' transportation vision and goals
- Addresses public concerns
- Potential to address the existing and future mobility needs of the corridor
- Sensitive to current and future land use
- Provides better access and circulation within and between major intersections

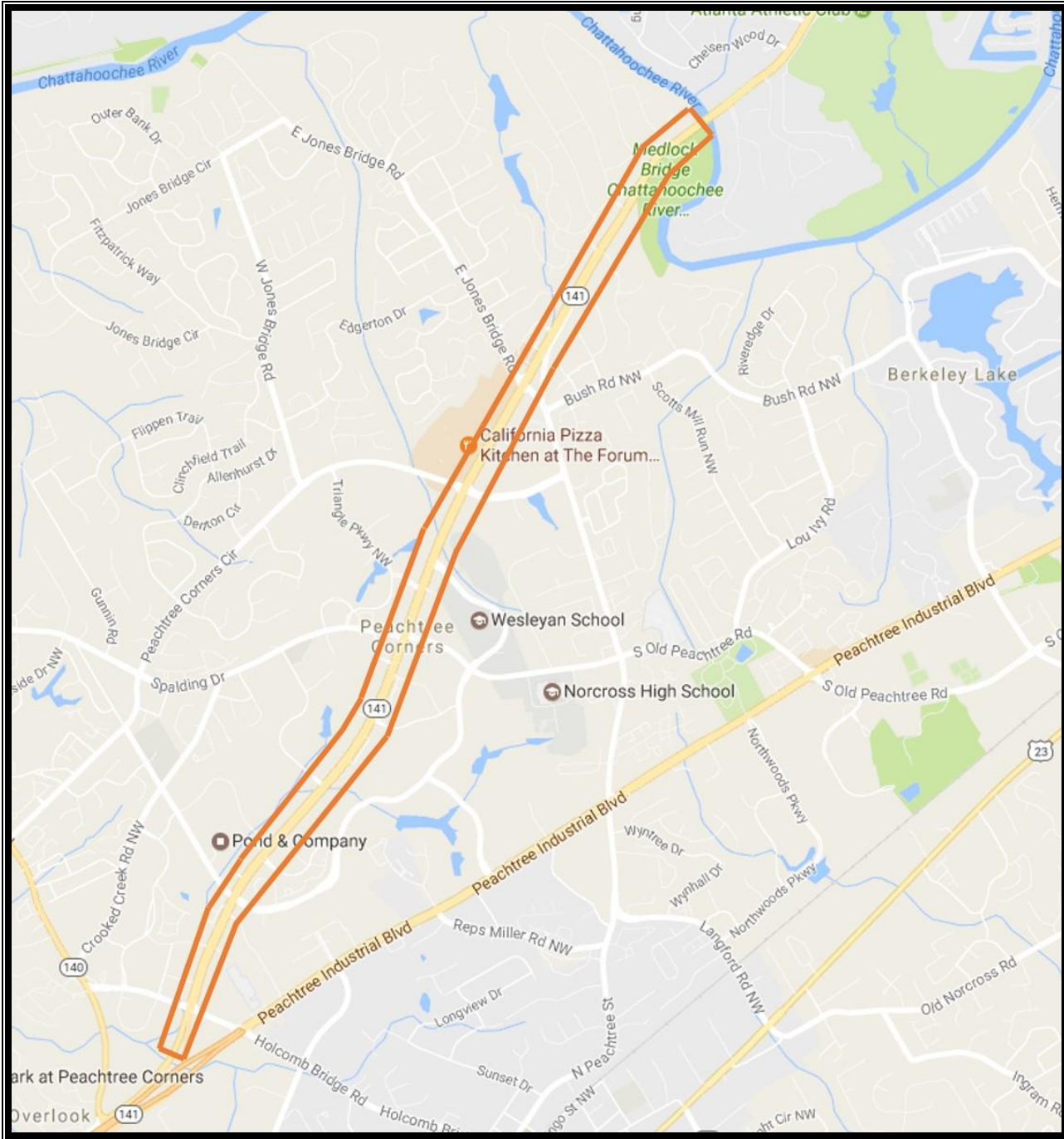
