MOTION TO APPROVE O2020-03-165 WITH VERBIAGE REMOVED FROM SECTION 2.2 ON PROPOSED AGENDA (ANY ESTABLISHMENT

THAT IS LICENSED FOR ON-PREMISES CONSUMPTION OF ALCOHOLIC BEVERAGES SHALL BE AUTHORIZED TO SELL UNOPENED BOTTLES OR NEW, SEALED GROWLERS OF BEER OR UNOPENED BOTTLES OF WINE CURBSIDE OR TO TAKEOUT CUSTOMERS ONLY DURING THE TIMES SPECIFIED BY ALCOHOLIC BEVERAGE LICENSE AND PERTINENT CODE SECTIONS. THE CITY MAKES NO REPRESENTATIONS AS TO THE EFFECT OF THESE TYPES OF SALES ON AN ESTABLISHMENT'S STATE LIQUOR LICENSE.), AND ADDITION FROM O2020-03-164, SECTION 2.6 (IF A BUSINESS IS LICENSED BY THE CITY TO SELL ALCOHOL FOR ON-PREMISES CONSUMPTION, SUCH BUSINESS, DURING THE EFFICACY OF THIS EMERGENCY ORDINANCE ONLY, SHALL BE AUTHORIZED TO SELL UNOPENED BOTTLES, OR OTHERWISE APPROPRIATELY SEALED CONTAINERS, OF ALCOHOL FOR TAKE-AWAY FOR CONSUMPTION OFF-PREMISES. ANY ALCOHOL LICENSEE WHO ENGAGES IN A COURSE OF CONDUCT PERMITTED UNDER THIS SECTION DOES SO AT THE LICENSEE'S OWN PERIL AS IT CONCERNS THE LICENSEE'S STATE LIQUOR LICENSE. THIS ORDINANCE MAKES NO REPRESENTATION AS TO THE LEGALITY, UNDER STATE LAW AND STATE ALCOHOL LICENSES, OF ANY COURSE OF CONDUCT UNDERTAKEN PURSUANT TO THIS SECTION), AND TO CORRECT SCRIVENER'S ERRORS.
